## Over a Century and still Fiddling

**Joe Kuhn**

Fiddlin' around for over 65 years



*On May 15, 1861 Alf Stipes played this fiddle as men and boys from van Buren County went to the Civil War. Joe Kuhn still plays the same fiddle today.*

Playing at a pie supper at Bone Cave, a square dance in Spencer or on his own television show in Florida, Joe Kuhn of Rock Island has fiddled around for more that sixty-five years. Joe began playing as a boy following his great grandfather, grandfather and father, who were all fiddle players. Joe had played with Bill Monroe, Benny Martin and many other bluegrass greats.

The fiddle he plays goes back many more years. It is a Grand Gerard that dates back to France about 1775-1820. To get the story on the fiddle we have to go back 155 years ago this May 15th and read the Civil War Diary of

Carroll Henderson Clark. It tells of the men and boys of Van Buren County going off to fight in the Civil War.

Here is an excerpt from the diary as it appeared in the Spencer Times Newspaper in 1911.

"It was understood by all that we would start on the 15th of May 1861. Spring opened early that year, and farmers were over their corn crops the second time. The 15th was on Wednesday, which was clear and beautiful.

We all met at Wiley Millers (now Goodbar). Our wives, sisters and sweethearts were there in great numbers. About 2 p.m. we told them goodbye and marched off to music of Alf and Joe Stipes fiddles and Lewis Ford's drum. Several of them never saw Van Buren County again. Remember this was in May 1861, We arrived in McMinnville late in the evening and the good people took care of us that night and gave us breakfast next morning."

As the men and boys marched off to the Civil War, Alf Stipes played and said, "Boy's, you are hearing sweeter music than that made by the barking of the Fox hounds as they chase the fox over Bone Cave Mountains"!

As a high school student Joe played at dances and traveled to different towns to enter contests. In the 1950s he had a band that played on WMMT radio in McMinnville. In addition to Joe, members of that band were Charles Webster, Joe Bob Basham and a girl named Dorothy Marsh. That girl who started with Joe's band would go on to become the famous Dottie West.

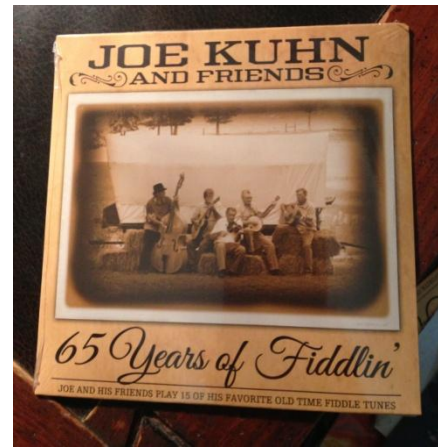
Joe was in wide demand as a fiddler for square dances and he often came to Black Bottom to play at square dances organized by Dot Page in the old building that stood across the road from Marti's Store next to Lewis Motor Company. It was here that Joe played with Van Buren County musician's like: Leon Hodge, Clifford and Carl Bouldin, Clifton Boyd, Joe Simmons, Jr. and others.

One event that he has a great memory of at the Spencer square dances is of Sheriff Perry Smith. Joe said that the sheriff would take his pistol out of the holster and lay it aside and square dance with the holster flopping up and down.

When WBMC radio went on the air in McMinnville in 1955, Joe became a country DJ and worked there until 1959. He then moved to Fort Myers, Florida and had his own television show on WINK-TV.

He returned to Tennessee in 1963 and became the general manager of WAKI radio in McMinnville. He later became part owner of the station and from 1968-1977 he was owner and manager of WSMT radio in Sparta, Tennessee.

Joe Kuhn says that fiddle still makes that sweet sound today. You can hear the sound on Joe Kuhn and Friends, 65 years of Fiddlin' a new CD Joe released in 2014. Great tunes like Orange Blossom Special, Draggin the Bow, Faded Love and others make that CD a treasure of great songs.



Joe says, " I always keep my bow rosined and ready, 'cause you never know when someone might want to hear a tune"!

And that is how a fine French violin became a "Tennessee fiddle"!
