

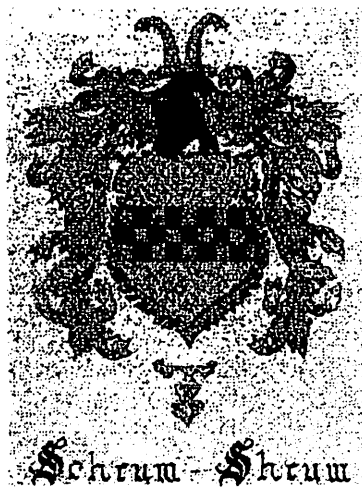

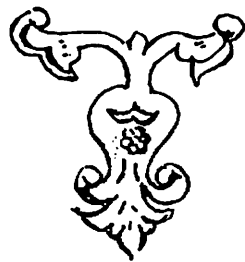
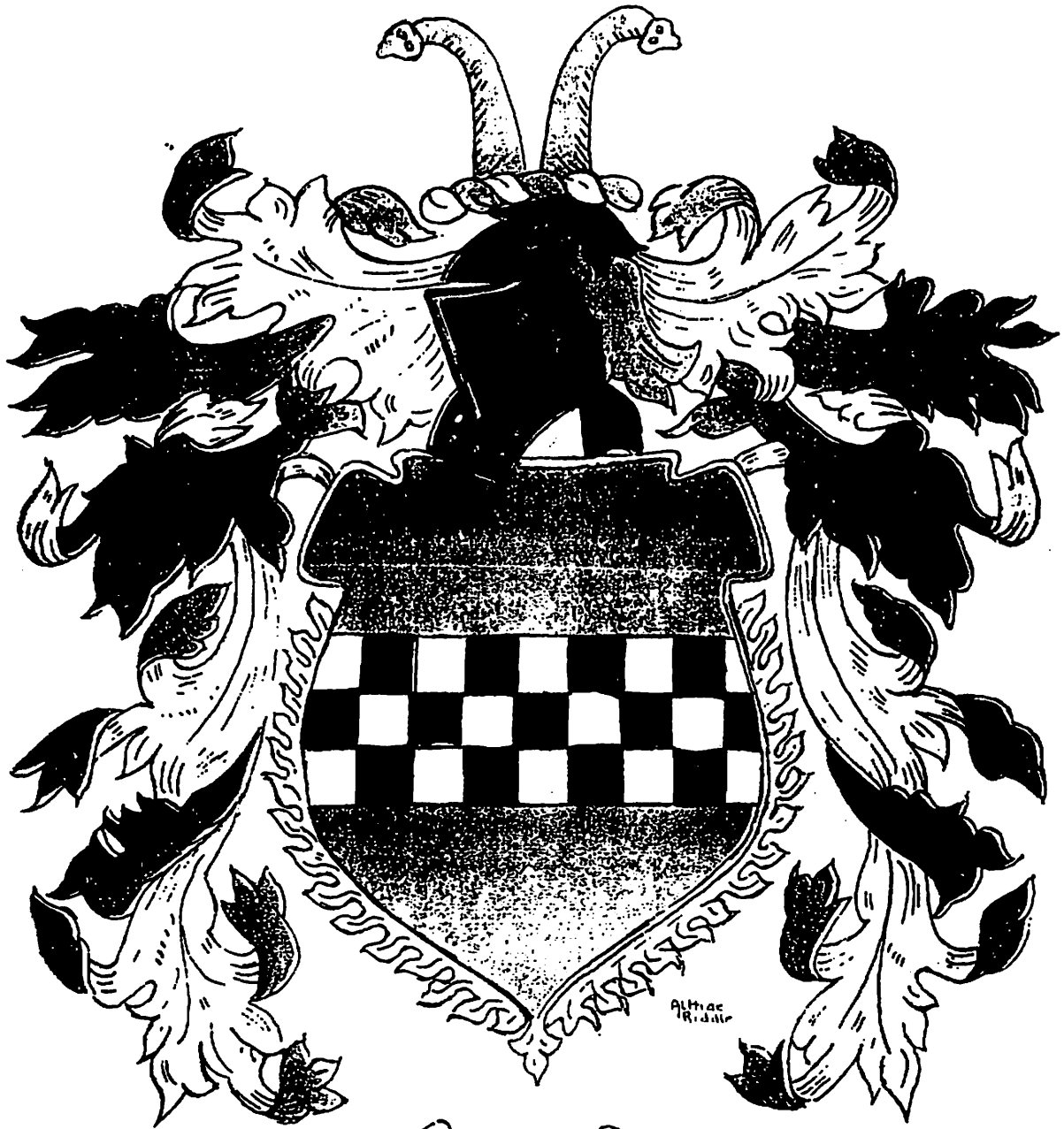

The Descendants of Henry Shrum "Fact or Speculation"

Listing 875 descendants for 9 generations.

10000. **Henry¹ SHRUM'** was born about 1775 in Lincoln County, North Carolina. He was the son of Johann Nickel "Nicholas" **SCHRAM** and Margaret **HELMIC**. Henry died in Marion County, Tennessee. He married **Susannah Dudero/TOTHEROW** 7 March 1797 in Lincoln County, North Carolina. She was born 1777 in Lincoln County, North Carolina. She was the daughter of John **TOTHEROW** and Mary **HOFFMAN**.

The German pronunciation for Totherow would sound similar to "Duderow" in the clipped, vowel accented, German, and might even be recorded as "Dudro".

It has been rumored that Susannah died (drowned) crossing the Little Tennessee River. This river originates in the Great Smoky Mountains of western North Carolina, and flows generally westward through Blount, Monroe then into Loudon County, Tennessee, where it becomes part of the larger Tennessee River. If she drowned on the migration westward, then from the limited census data on Henry & family, it appears that Henry may have remarried.

From the "SHRUMS HISTORY BOOK" by James Roy Shrum:

"Henry Shrum, son of Nicholas Shrum, pioneer to North Carolina. We found Henry Shrum listed in the 1830 census of Bledsoe County, Tennessee on page 270. His age 50-60 years. Children: two males, one male age 15-20, one male age 5-10. Three females, one age 50-60, one age 10-15, one age 15-20. This man would have been born about 1775. In the land grant records in Nashville, Tenn., Henry Shrum, Land Grant No. 982 - Hundred acres of land in Bledsoe County, Tennessee"

¹ **RESIDENCES:** Henry went westward about 1809, sold all his property to Jonas Friday. Moved from North Carolina to Tennessee.

ORIGIN OF THE PENNSYLVANIA GERMANS

Extracts from a brochure by Professor Russell N. Gilbert
Susquehanna University
Written for the Pennsylvania Historical Society

"Early in colonial times the different sects, such as the Amish, and later the church people like the Lutherans and the Reformed, came from various sections of central Europe. Most of them emigrated from the countries or states bordering on the Rhine".

"The Rhineland or the Palatinate has often been called the cockpit of Europe because of the constant clash of many peoples and tribes since Roman days. The Thirty Years' War (1618-1648) with its bloodshed, raping, murder, robbery and pillage had its devastating effects upon the birthplace of the Pennsylvania German forefathers. It was a war which stifled Germany herself for at least a century. It reduced the population of the Palatinate from approximately 500,000 to fewer than 50,000. War and carnage were not a new experience for the Palatines; their soil had been drenched with the blood of Celts, Romans, Alemanni, Burgundians and Franks through the centuries".

"Into a background of struggle and disillusionment there came a ray of hope - the personality of William PENN. After an imprisonment of six months for preaching Quaker doctrines in England, he became missionary-minded and journeyed to Holland and Germany in 1671-72 and again in 1677. These visits revealed to the Rinelander PENN's similar religious ideas and his understanding heart for the oppressed".

"But hardships continued to come with the repeated invasions (1674, 1680, 1689) by the despotic French King Louis XIV. During the last of these Heidelberg, Mannheim, Speyer, and Worms succumbed to the ravages of the French soldiery. Hundreds of towns and villages were laid waste, and countless thousands of Palatines were left homeless and destitute, with the farms made worthless to this peasant folk. Beside the tragic effects of war there were many other factors which helped to arouse the adventurous spirit of the Rhineland inhabitants; religious quarrels; the revocation of the Edict of Nantes on October 18, 1685, with the stipulation that the children in France be educated in the Catholic faith, and that all Protestant Churches be demolished; the recognition of only Catholics, Lutherans and Reformed; the rejection and outlawing of sect worship; the War of the Spanish Succession; the harsh winter of 1708-09; the increase in taxes; attractive offers by land speculators, by ship companies, and by "Newlanders" whose usual reward was seven dollars for every immigrant; and extensive advertising by Benjamin FURLEY, Francis Daniel PASTORIUS, and Daniel FALCKNER. In this dark chapter of European history, PENN's promise appeared as a distant, beckoning light".

"October 6, 1683, marked the first record of German history in America. The good ship "Concord" arrived at the port of Philadelphia with thirteen families, mostly from Krefeld, a city on the lower Rhine within a few miles of the Holland border. With harmonious zeal under the leader PASTORIOUS, they established the first permanent German settlement in America and appropriately named it Germantown".

The earlier settlers, up to about 1727, had enough money to pay for the passage and also to buy a farm. As a class the early Germans included many of the best educated and most prosperous of the Germans who came to colonial Pennsylvania. On the other hand, after 1727 many came as indentured servants, often erroneously called Redemptioners, a term found neither in the indentures nor in legislative acts. They voluntarily submitted to the servitude necessary to pay for the passage to America. Most indentures lasted from two to seven years but there were also the contrasting terminal lengths of six months and twenty years. Often families were separated for service among different land owners. Here were men, women, and children who sold themselves into slavery, as it were, in order to gain ultimate freedom".

"The time of emigration determined not only the number but also the type and character of the Germans who came. The earliest settlers of 1683 assimilated with the English and failed to form a racial or linguistic island whereas those of the first decade of the eighteenth century were more resistant to outside influence. The Germans who founded a permanent home in Pennsylvania up to 1700 belonged largely to many sects which had fled from religious persecution and economic hardship. This included the Mennonites, Amish, Pietists, Dunkards, Schwenkfelder and others. The years between 1727 and the American Revolution brought the church people (Lutherans and Reformed) with the Moravians placed somewhere in the medial position between church and sect".

"One must remember that there were distinctions between the sects and church people. They not only came at different times but they were different. One example may be cited here. On the whole, the sect members opposed military conscription; the church people, whose forebears had willingly served in the German army, conned the American soldier's uniform, like the dramatic John Peter Gabriel MUHLENBERG in Woodstock, Virginia, who realized early in 1776 that "there is a time for preaching and praying, but also a time for battle, and such a time has now arrived". Although the average Pennsylvania German hated war, his greater love of freedom readily transformed him into an excellent soldier. A few sects, religiously believing in a gospel of non-resistance, outlawed buttons, to them the symbols of a uniform and strife, for the more peaceful hooks and eyes. Besides war, the Amish, Dunkards, Mennonites and Schwenckfelder opposed legal procedure, and educated clergy, forms and ritual".

Year of the Destroying Angel - 1738

The Ships of the Palatine Fleet in 1738 (By Klaus Wust)

Three Palatine transports are known to have left from Amsterdam. The pink, Amsterdam, Captain Joseph Willson commanding, arrived safely in NY on Oct 12th with "upwards of 300 Palatines," many of whom were actually from Wurttemberg. One day later Captain Christopher Ratsey came in with his galley, Anne. There was no indication of any unusual health problems in the terse newspaper reports. Willson had carried on regular runs to NY since 1734, Ratsey had brought 173 German passengers in 1737. In view of the assertion by several contemporary writers that the epidemic had its origin in the camp sites at Kralingen, it is surprising that one of the hardest hit vessels was from Amsterdam. The sickness might well have already existed on the Rhine boats. The ship, DAVY, qualified in the port of Philadelphia on October 25th. The next day the [Philadelphia] Gazette released a story of this voyage.

GAZETTE REVEALS HORRIBLE STORY OF VOYAGE ABOARD "The Ship DAVY"

The captain, both mates and 160 passengers died at sea. It was the ship's carpenter, William PATTON, who brought the ravaged vessel up the Delaware. Patton listed 74 men, 47 women and NO CHILDREN as the remaining passengers. Only 40 of the men were well enough to come to the courthouse [loyalty oath]. In this context, the Gazette commented for the first time on the general situation: "Most of the Ships which bring Dutch [German] Passengers this Year have been visited with a Sickness that has carried off great numbers." (46) Send-Schreiben, 23 Pennsylvania Gazette, Oct 26 1738; SH I, 233-6 [NOTE: Jacob & Anna Maria and their sons: George, David and Nicholas, arrived in America in 1738, aboard this ship DAVY.]

Next appeared the long overdue St. Andrew, commanded by the favorite ship captain of the Germans, John Stedman. Several letters from passengers of his previous five runs between Rotterdam and

Jacob and Anna Maria with sons, George, David and Nicholas arrived in Philadelphia on 10/25/1738 aboard the ship DAVY. If daughters were along they did not survive as they are not mentioned in ship records. The oldest two sons stayed in Waldmohr.

They came as indentured servants to pay their passage. They were ordered to the Pennsylvania colony because they were needed to build the social system in that area. It is believed they were engaged as weavers to pay their passage.

In Gibson's History of York Co., PA., page 516, a census of York made in 1738 (noted on letter book A, page 130, 8/29/1759, listed Jacob Shrom as a weaver, owned 1 horse, employed 4 persons.

Jacob and Anna Maria lived and died in Manchester Township, York County, PA. They are buried in Prospect Hill Cemetery in York, PA. (Section A, Lot 5; from office left hand side on traffic circle, road to right, top of circle.)

WILL OF (ANNA MARIA SRUM) MOTHER OF "NICHOLAS"

P. GEO. SHUENSON, D.R.

IN THE NAME OF GOD, AMEN; the thirteenth day of July, in the township of Manchester in the county of York, and province of Pennsylvania, being weak of body but of perfect mind and memory. Thanks be to God, therefore calling to mind the mortality of my body and knowing that it is appointed for all woman-kind once to die, do make and ordain this my last will and testament that is to say, principally and first of all I give and recommend my soul unto the hand of God that gave it and for my body, I recommend to the earth, to be buried in a Christian like manner at the discretion of my executors, nothing doubting but at the general resurrection I shall receive the same again by the mighty power of God, and as touching such worldly estate where-with it has pleased God to bless me in this life, I give, divide and dispose of the same in the following manner and form.

IMPLEMENTS: It is my will and I do order in that in the first place that all my debts and funeral charges be paid and satisfied; and it is my will namely, my three sons, George Srum, Nicolas Srum and David Srum shall have Five pounds, each of them; my son Nicolas is paid and George is paid it.

It is my will that my son, John shall have lace and a Little Jacket without sleeves, to my daughter-in-law, Nicolas, his wife Jacket for older girl a petticoat, I order my son George Srum his wife Jacket and her daughter a petticoat and an Iron Pot, George Srum's eldest daughter I order a Calico apron for my son George, his daughters, and my son Nicolas's, his daughter is to have Calico aprons, and muslin handkerchief, and only son John is to have the Chest, and my son George is to have my old shawl and the rest of my effects shall be equally divided excepting (10 yards of Calico is to be bought for one yard to be given (Susanna Mari) Phillipi Kreaufer's daughter and (Anna Christina) John Pence's daughter, I do order a piece of mushim cloth, all together to my son John Srum all the notes, bills, bonds is to be divided equally likewise I constitute and ordain, Philip Kreafer and Henry Kreafer of this my last Will and Testament and do hereby all only disallow, revoke all other wills concerning this and no other to be my last will and testament. In behalf I have let my hand and signed, sealed, published, pronounced and delivered by this will and testament in the presence of subscribers in the year (anne Demin 1754)

IN THE NAME OF GOD, AMEN.

I, Nicolas Shrum of the County of Lincoln and State of North Carolina, finding myself in a bad state of health but of perfect mind and memory and calling to mind that it is appointed for all men once to die, do make and ordain this to be my last Will and Testament for to dispose of what worldly estate it has pleased God to bestow unto me in this life, in the following manner after my decease,

Item I: I give and bequeath unto MARGARET, my well beloved wife the command of the Plantation whereon I now live, until my son HENRY comes of age, as also of the family, and to take her choice of one horse creature, also of the cows and four sheep for her own use, and the horse and tackling, two pots, the pewter, wooden and earthen ware belonging to the deceased and one bed and furniture, also her saddle and one spinning wheel. And in case that HENRY and his mother can not agree together on the land or in the house, after HENRY comes of age, he is to build her a good decent house with two floors, chimney and door at any convenient spring where his mother sees cause, and keep her in constant firewood, as also I leave my wife liberty to clear any quantity of ground not to exceed ten acres where she sees cause on said land, for her own use and the one third part of the benefit of the orchard where I now live.

My wife is to move her horse and other stock of cattle and sheep with her, and other property above mentioned to her pwn house when built and when she sees cause, and to remain with her during widowhood. And providing that my wife should happen to marry again she is to deliver all the above property to the executors of this will and the land and house to HENRY. If she dies a widow to dispose of it as she sees cause. If she marries, she is not to give up her horse and saddle, wheel and bed but them she may take with her.

ITEM 2: I give and bequeath unto my son HENRY all that tract or parcel of land whereon I now live as also two other tracts adjoining the same, the whole amounting to three hundred and eighteen acres, as will more fully appear by the different patents thereunto belong to him, his heirs and assigns forever, to have and to hold, after giving to his mother the above mentioned privileges and giving her yearly during her widowhood fifteen bushels of wheat, ten of corn, and five of rye, two hundred weight of good pork, one hundred fifty weight of good beef, and sow and plow half an acre of good ground in flax for her yearly.

ITEM 3: I give and bequeath to my son PETER the sum of five shillings; also my son NICOLAS the sum of five shillings.

ITEM 4: I give and bequeath to my five eldest daughters, viz: MARY, ELIZABETH, KATREENA, CHRISTIANA, and MARGARET the sum of five pounds cash to be paid out of my personal estate.

ITEM 5: I leave to my daughter HANNAH one brendled two year old heifer, also to my daughter, SARAH, one black cow four years old.

ITEM 6: I leave to my youngest sons, JOHN and DAVID, the two tracts of land lying on Buffalo, joining George Patterson and Joseph Carpenter land containing five hundred acres as the different patents will more fully make and appear, to them their heirs and assigns, to be equally divided when the eldest of two sons comes of age. But in case either said JOHN or DAVID should die without any lawful issue before the other comes of age, the whole shall fall into the hands of the survivor.

ITEM 7: I leave that tract of land on Hoyles Creek joining Friday's land containing two hundred and thirty acres to be sold by my executors after my decease and the money arising from the sale, one part to be put to that use to school my four youngest children vis: JOHN, DAVID, SUSANAH, and BARBARA.

And the said JOHN and DAVID when schooled so far as to read, write and arithmetic, to be bound out of such trades as my executors see cause with their own consent not exceeding four years each. And my son HENRY is to support the four children for vittles and clothes during their schooling, provided it not exceed the term of three years, out of the benefits of his land and the remainder of said money to be divided, with the other cash and personal estate.

ALSO I order all my personal estate to be sold by my executors the spring after my decease at public sale and the money arising from the sale to be equally divided amongst my eight following children: JACOB, HENRY, HANNAH, SUSANNA, JOHN, DAVID, SARAH, and BARBARA.

All things mentioned in my will before the order of sale is hereby excepted and all legacies paid before a division is made of the personal estate and the remainder of the price of the land, price after schooling the children is to be equally divided among the six last mentioned children, viz: HANNAH, SUSANNA, JOHN, DAVID, SARAH, and BARBARA.

And for the execution of this my last will and testament, I hereby nominate and appoint John Fullenwider, Esqr. and my son, JACOB SHRUM, to be my whole and sole executors of this will, and I do hereby disannul all former wills and testaments whatsoever ratifying and confirming this.

IN TESTIMONY WHEREOF I have hereunto set my hand and seal in the presents of the subscribing witnesses this 24th day of August, 1791.

John Nicholas married Anna Catherine Koener on Jan. 9, 1749 and they had eight children. After her death in the 1760's, he married Margaret Hemlic in the Shennandoah Valley in Virginia. They were the parents of seven children. (5,7) After they married, they continued to what is now Winston Salem. They would have then come to the vicinity of Salisbury, North Carolina. This was a major route to the section of the country where Moravian Bishop Spangenburg crossed the Catawba River where the buffaloes shoaled the river. The present day Buffalo Shoals road is a ridge road where you do not have to cross water from the Catawba River all the way to Lincolnton. Some of the settlers left the great wagon road and came into this section of the country by way of this early road.

Nicholas' first land grant was for 230 acres on Shoal Creek, later called Sulfur Branch. His son, Jacob had adjoining land. His son Peter's land was on the Buffalo Shoals Road near the headwaters of Leeper's Creek.

Nicholas had various occupations. There were many transfers of land to him involving other people. He served on many grand and petty juries. He was a foreman of a road from Lincolnton to Tuckaseegee foard, which crosses the Catawba River in the Mount Holly area. Anyone who lived within five miles on either side of the road had to work on the road for a certain amount of time during the year, thus helping pay their taxes. He was a Lincoln County constable and cried "Vandue" which is the auctioning of estates. (5) Nicholas died in 1793 in Lincoln County, North Carolina. (7)

John Nicholas Schram was married to Anna Catherine Koener on January 9, 1749 at the Evangelical Lutheran Church, York County, Pa. Their children are listed below.

Mary Magdalene was born on January 19, 1750 and baptized at the First Reformed Lutheran Church Zion, York County.

Anna Elizabeth was born June 8, 1751 and baptized at the same church.

Catherine Elizabeth was born on March 6, 1753 and baptized at Christ Evangelical Lutheran Church.

Maria Christina was born on December 22, 1754 and baptized at the First Reformed Lutheran Church, Zion.

Maria Margaret was born on February 8, 1757 and baptized at the First Reformed Lutheran Zion Church.

John Jacob was born on November 11, 1758 and baptized in January 1759 at Christ Evangelical Lutheran Church.

John Peter was born on September 25, 1761 and baptized at Christ Evangelical Lutheran Church.(8)

About 1800 the children of Nicholas began leaving the Lincoln County area of North Carolina and going to the western states. Few records for that period of time are found, except for information about Peter.

Peter was a Revolutionary War soldier. He enlisted in the militia just after the battle of Ramsour's Mill. The oral story is that on June 20, 1780, Peter was out hunting near Ramsey bottoms, heard the firing at Ramsour's Mill and rushed over to see what was happening. We do not know whether he got there during the battle or afterward. (5) He served as a member of Captain John Armstrong's Company. He was captured at the battle of Fishing Creek on August 18, 1780, carried to Charleston, SC, and left aboard a prison ship until September 1, 1780. He was confined to barracks until April 1781, at which time he was transferred to a prison ship where he remained until exchanged at Jamestown, Virginia, July 20, 1781. At this time he was discharged from the army. (9)

He came back to North Carolina and the oral history from the Mostettler family says that Peter Mostettler and Peter Shrum were wagoners after the war. Conastoga wagons made trips between Charleston, SC and the piedmont sections of North and South Carolina. They took goods to Charleston and brought goods back to the mercantile in the frontier towns. These wagons would travel approximately twenty-five miles a day. They would camp overnight and the next day continue their journey to Charleston or even to Philadelphia. It was probably on one of these trips that Peter married Margaret Epley in York, PA. (5) They had ten children. (9)

Jacob married Kitty Shetley on March 19, 1789. They had several children who later went to Missouri. Jacob died on April 18, 1815 and Kitty died about the same time. Jacob was a Revolutionary war soldier and is listed in the D.A.R. Patriot Index, having served in the York County, PA Militia. (7)

Nicholas married Betty (Betsy) Hostetler on April 17, 1784. They lived in Smith County, Tennessee. He is buried on the dry run of Goose Creek.

Maria Margaret married Martin Hoyle and lived in Cleveland county, NC.

Henry married Susan Totherow on March 7, 1797. In his father's will, he was designated to take care of his mother. His family later moved to the vicinity of Tracy City, Tennessee.

John married Lizzie Totherow .

David married Becky Garner on January 11, 1809.

Susannah married Peter Epley on March 27, 1801, and moved to the vicinity of Marion, NC. They are buried at Silver Springs Baptist Church, near Marion.

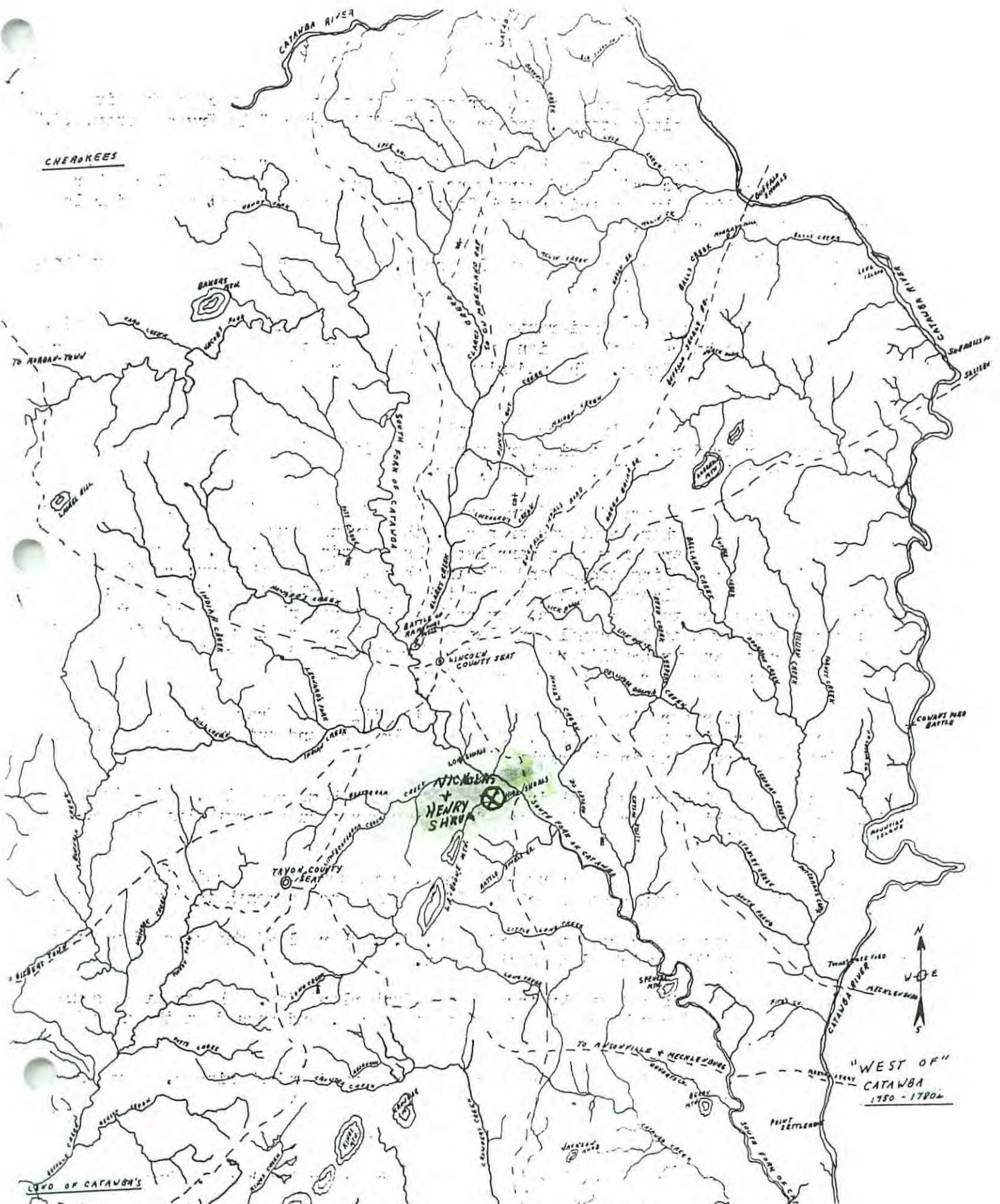
Dear Joyce,

It was good to hear from you, The surprise meeting of you and Andrew with the Lawings' Amazes me!! Especially that they saw a connection with the name Shrum.

I was at the Homeplace of Henry Shrum, that he lived at, to look after his mother Margaret about a month ago, With Wayne Shrum of Richmond Va. This was the Land Nicholas first received as a state Grant in 1769 while this area was Mecklenburg Co., He actually was here by 1767 for his name appears as a witness on a land Transaction bearing that date.

Henry Shrum + Susannah Dudsons wedding on 7 Mar. 1797 Was Witnessed by JOHANN DUDROW the names are written in German. The name DUDRO OR DUDEROW was Anglicised with a (T instead of the harsher D,) and today spelled (TOTHEROW) this family intermarried with the Shrums locally and travelled to Tenn., Missouri, and were on the First Wagon Train leaving Independence Mo. for Oregon.

Henry sold the Homeplace in 1809 to Jonas Friday and went to Tennessee. There must be a very interesting Contemporary History connected with the family of which

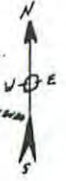

The map on the preceding page was prepared for those of our clan who live elsewhere over the United States, and are not familiar with "Old Tryon County, N.C."

The scale is accurate, and the names of our waterways are those used since colonial times. Concerning land conveyances, you can approximately place where your forebears lived by comparison with State Highway maps of Gaston and Lincoln Counties, North Carolina.

The map does not encompass all of Old Tryon, just the present Gaston, Cleveland, Catawba and Lincoln Counties.

This area received its immigrants from the areas of Pennsylvania and Virginia. The sons and daughters of these pioneers proceeded west to settle Tennessee, Kentucky, Missouri, and Texas. The majority of these were of German or Scotch Irish descent.

Agriculture was the main source of employment but the more daring were hunters, scouts or traders. Most pioneers were diversified in skills; making their own shoes clothing, utensils, furniture, etc.

The women were resourceful and preserved food for the coming year. I remember the old smoke-house where meat was prepared, the spring house where sauerkraut was put in earthen jars or wooden barrels; also putting potatoes, cabbage and turnips in hills; peeling apples and slicing them to dry in the sun; rolling old Cardui calendars or almanacs into paper matches that would light from coals; gathering sassafrass roots to make tea. Every home had an herb garden and orchard. Study was done by a tallow candle and later on the kerosene lamp. In this age of canned biscuits and tranquilizers we wonder how they lived. I would say they were comfortable and more serene than we are today.

The only literature in most homes was their Bibles and Prayer books passed down from generation to generation. Some had almanacs and put great store in planting and harvesting in the right sign.

Most of the pioneers were their own doctors with home remedies. Mid-wives delivered the babies. Survival of the fittest was not just a myth but the accepted way of life.

Social events consisted of house-raisings, corn shuckings or quilting bees, and preaching by an itinerant preacher. If he came once a month they were fortunate.

Their products were carted to Charleston, S.C. where lead and gunpowder could be had and the frills which pleased the women.

Salt was hauled from Kentucky through the Cumberland Gap. The greatest source of news was the trader who traveled to distant places, and passed on the news by word of mouth.

The legacies passed down to us should be preserved and cherished. May our own lives measure up to theirs.

Our family history began in the southwest part of Germany in the Palatine area. Jakob Schramm and his family lived in Waldmohr in Zweibruecken. (1)

Jacob Schram and his son, Georg Schram arrived in Philadelphia on Oct. 25, 1738 aboard the ship, "Davy" and qualified at the Philadelphia courthouse as Georg Shram and Jacob Shram. (2)(3) While they were aboard the ship, many people became ill and died. An article that appeared in the Pennsylvania Gazette on Oct. 26, 1738, stated that "last arrived here the ship Davy from Holland and Palatine. The captain, both mates and many passengers died and the carpenter brought in the vessel." Jacob and Georg Schram survived this perilous voyage. (5)

Jacob and George Shram qualified at the court house at Philadelphia, that is, they met their contract, received their appointments and began to work for their passage over and then to pay for the other family members to come. The Palatines were, for the most part, impoverished people. Most of them came as indentured servants that paid for the trip over by the sweat of their brow. They were ordered for the Pennsylvania colony because they had the particular skills that were needed to build the social system in Pennsylvania. It is believed that Jacob and George were engaged as weavers to pay for their passage. This is based on the will of Anna Maria who had very little money, but she gave quite an abundance of cloth to her children, grandchildren, and Godchildren. (5).

It was several years after 1738 that Jacob's wife, Anna Maria, (born 1702) and the other children, Nicholas (b. 1730) and David came to America. (1) We do know that Anna Maria was in the colony by 1745. (4) A fourth son, John, was born in York, Pennsylvania. (6) We also know that their pastor at Waldmohr in Zweibruecken probably removed their names from the church membership in 1749. (1)

Jacob Shram died in 1748, and his wife, Anna Maria, died on July 30, 1754. They both lived and died in Manchester Township, York County, Pennsylvania and both are buried in Prospect Hill Cemetery. (7) Her will is included in this volume. See page

According to the original baptismal records of Rev. Jacob Lischy, York County, Pennsylvania, 1744-1769, George and Elisabeth Schram's daughter, Anna Maria Schram was baptized on May 21, 1749. Their son, John George Schram was baptized on Jan. 19, 1752. George and his family probably traveled through the Shennandoah Valley of Virginia and later settled in Orangeburg, South Carolina. (5)

John Nicholas married Anna Catherine Koener on Jan. 9, 1749 and they had eight children. After her death in the 1760's, he married Margaret Hemlic in the Shennandoah Valley in Virginia. They were the parents of seven children. They settled in North Carolina. (5)(7) (more info later)

We know very little about David and his family, but we think they settled in the Ohio Valley. (5)

John was born in York County, Pennsylvania and later married Eva Margaretha. Only three children of John and Eva are known today by name: Henry, George, and John. The 1790 census lists another female living in this household, but nothing is known of her. (6). (more info later). In 1786 John owned 300 acres of land in Westmoreland County, western Pennsylvania.

According to research done in York County, Pennsylvania, the Shrums did not own any land there. They were busy paying for their passage from Germany. Because of the availability of land, North Carolina provided an opportunity for some of them to redeem themselves and to own land. (5)

Through The Years With **SHRUM'S**

A complete history of our progress through the years would make a book. Such an undertaking has not been attempted. But we are endeavoring to give you a condensed compendium of our steps forward as well as show you we are complying regularly with the stringent regulations which safeguard our good name.

For half a century we have engaged in the dairy business. The late William F. Shrum, the present owner's father, started the business and delivered milk, eggs, and butter to the first families of Jeannette. At first deliveries were made weekly, and the milk was conveyed in five and ten gallon cans. Customers produced their own containers, and the milk was measured out to them on the street. As the business grew, we made deliveries twice a week and later on daily. From this modest beginning we have grown to our present size and deliver over two hundred gallons a day in the most modern manner.

We are proud of the fact that we have not only developed a modern delivery service but we have been leaders in other ways at home and throughout the state through the years. As early as 1895, the first pure bred REGISTERED JERSEYS were purchased and became the backbone of our present herd. In 1901, the first CHURN TEST in this area on butter fat production was made on butter churned by the late Mrs. W. F. Shrum. In 1903 we took a step forward by having our entire herd tested for TUBERCULOSIS at our own expense. Tests have been run regularly ever since thereby giving us an accredited herd for many years.

One of the first BABCOCK TESTS for fat production in the State was made at our farm in 1904. Our first BLOOD TEST, run in 1923, was very outstanding and gave us the distinction of having one of the first herd to be tested in the County. We continue to run these tests regularly at our own expense under the direction of the Bureau of Animal Industry and supervised by both the State and Federal Departments of Agriculture.

In June 1935, we came forward with our CREAMLINE LICENSE, which gave us the privilege to use the registered trade mark and gave us the rank of not only being the only dairy in the County to have this privilege, but one of the fifteen in the entire State at the present time. Only the dairies which meet the strictest sanitary standards for production methods, and herd health required by the State and the American Jersey Cattle Club, the national organization of purebred Jersey cattle, are licensed to use the registered Jersey Creamline Trade-Mark. Next came the GRADE "A" LICENSE from the State in September 1936, which also gave us a first in the County. In accordance with the requirement of the law, all the men that handle the cows and milk are examined periodically by a physician, bacteria counts are made, special caps are used and many other precautions taken to deliver the best Jersey milk to you produced under the best possible conditions. Our latest step, just completed, is a permanent record card for each of our 110 animals, with all such data as name, date of birth, health record, production record, pedigree, reproduction record, etc. This new system will enable us to keep a quick, accurate lifetime check on all our animals.

We are happy to help celebrate Jeannette's fiftieth anniversary, and as in the past, we are planning to move forward and to supply you with the same high quality dairy products as you have been receiving through the years gone by.

I am forwarding an artists' sketch of the castle (as it may have appeared about 1610). This was done by a Horst Hess. The sketch shows the existing stone walls and remains of the parapets in dotted lines. The castle is much larger than I could have imagined. When it was destroyed by the French, it was by fire, not by tearing down the stone. Most of the high structure was wood.

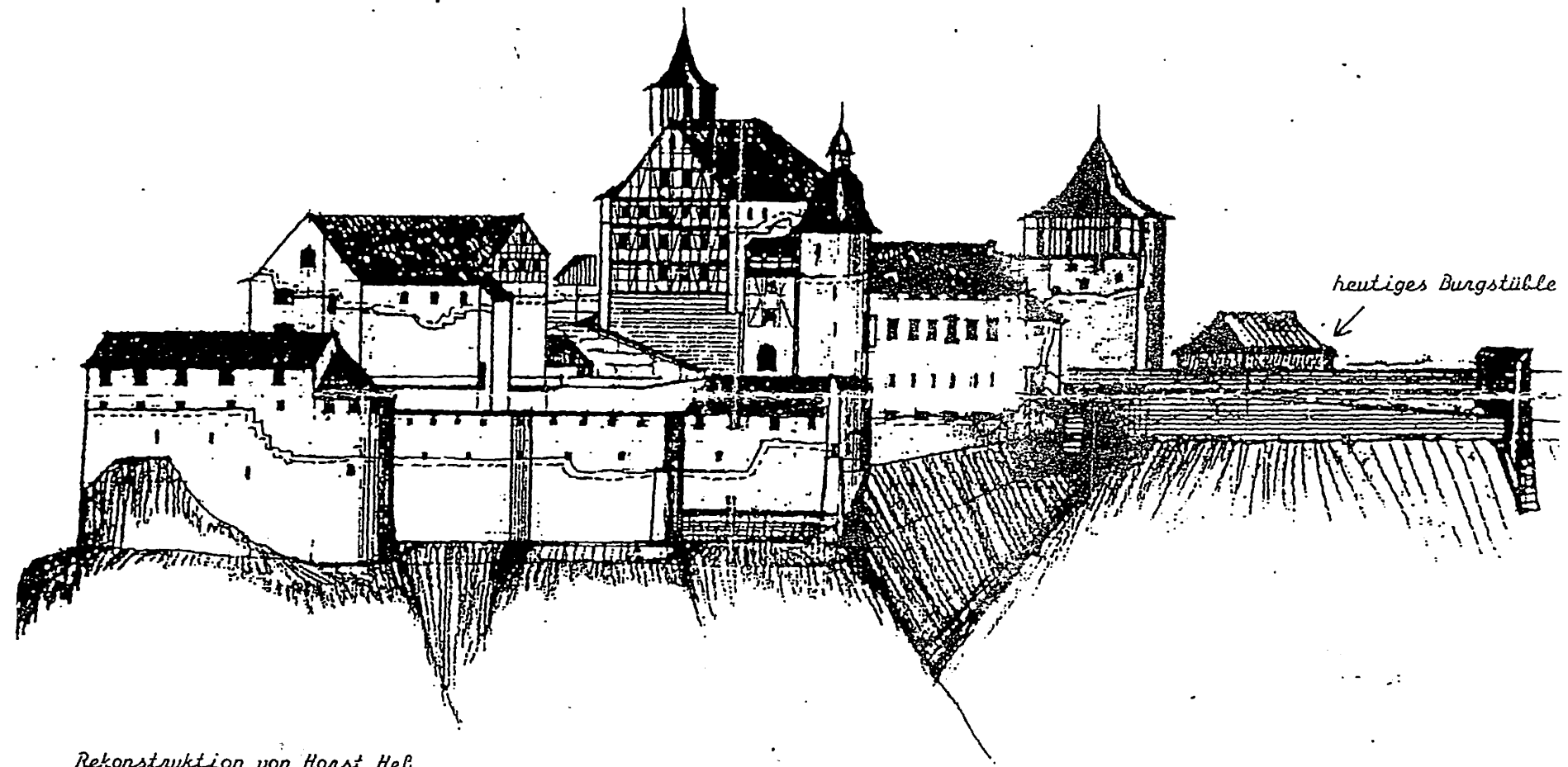
The section of the picture marked "Burgstube" is where a modern inn has been built, and where Joyce and I spent the night. The inn restaurant was quite nice, the food excellent. The price was about \$65.00 U.S., quite reasonable for Europe, which included our breakfast/brunch the next morning.

It was quite foggy the afternoon and night we were there, so my pictures did not turn out as well as I would have hoped.

The HohenSchramberg (High Schramberg castle) is on top of a ^{high} ridge of land overlooking the town of Schramberg. I would estimate the castle is over 1000' higher than the town, and the slope down is steep on three sides. The land to the north slopes away very gradually into woods and fields. There are at least two roads up to the castle, one dirt and one paved which meet about 1/4 mile before the castle, then follow the ridge line south + west to the castle + inn.

There is an eerie feel to this place, but not in an unpleasant sense. I felt secure and almost at home wandering around the castle remains, but get goose bumps writing about it.

RUINE HOHENSCHRAMMBERG

The ruin of castle "Hohenschrammberg" is situated high up about 2135 feet ("650 meters") steep and nearly upright above the "Five-Valley- And Clock- Town" "Schrammberg". The mountain crest "Hochsteig" which is situated behind in a northwestern direction is even 493 ("150 meters") feet higher. The "castle landlord", Franz Moosmann, and his wife invite tired hikers and travellers to relax in the "Burgstueble" (name of the attached restaurant) close to the ruin. The tiled stove provides good warmth in winter.

The "Schlossberg" (hill on which the castle was constructed) was supposed to be impregnable on three sides and was therefor fortified in the 15th century. The larger castle which was established later was leveled down in 1457. This was the time when "Hans von Rechtberg" resided on "Ramstein" and when "Ramstein" was burned down by the "Staedtebund" (society of the middle-aged towns). The extremely pugnacious "Hans von Rechtberg" sold his little villages "Gammerlingen" and "Hellingen" which were "Hohenzollern" descent establishing the castle Hohenschrammberg" from 1457 to 1459 which cost him 15000 "Goldgulden". This knights' castle was regarded to be one of the most fortified castles in "Schwaben" because of its extraordinary thick walls. "Duke Eberhard the 1st im Barte" sieged the castle in 1464. "Hans von Rechtberg" tried a lunge attack and was wounded by an enemy arrow at the "Hornberger Steige". He died because of his wounds. His son inherited the castle first, later it was his son in law "Hans von Landenberg". Christoph, son of "Hans von Landenberg" sold the castle to "Rochus von Staffelfelden" in 1547. "Rochus von Staffelfelden" was a great benefactor who led the Counter-Reformation and ascertained the castle to become a village.

During the "30-years-war" (1618-1648) the castle was sieged by "Konrad Widerhold vom Hohentwiel" ordered by "Eberhard the 3rd" and conquered. The "overseer Christoph Benz" had gotten the permission to honourable march back with his troops. In 1634 castle and the "Schrammbergs" came under control of Austria, in 1805 back to "Wuerttemberg", and "Schrammberg" has been ascertained to become a town since 1867.

The knights' castle came under control of the "Earl von Bissingen" in 1648. Troops from French emperor "Ludwig XIV" destroyed the castle by the means of fire in 1689. "Hohenschramberg" has been a ruin since.

According to "Earls von Bissingen's" wife the ruin was named after her the "Nippenburg". The walls fell apart until the current owner together with the state of "Wuerttemberg" stopped the decline.

The family of the "Earl von Bissingen" has hold the rights for appointments to the parish "Schrammberg" and the nearby parish "Lauterbach" since. Both the "Bissingens" and the "Nippenburgs" were famous Earl- houses at that time in "Schwaben". "Earl Ferdinand" who lived 1749-1831 defended "Tirol" as a governor and his son, "Cajelan" was appreciated as governor of "Tirol", "Vorarlberg", and "Venetien". He had lived on "Schrammberg" since 1860. He was a decisive advocat of catholic affairs in the regional and in the empire parliament. The current leader of the "Schwaben"-lineage of the "Bissingen"-family is "Earl Cajelan von Bissingen und Nippenburg". He was born in "Schrammberg" on 26 April 1870 and had resided for a long time on castle "Hohenstein" nearby "Rottweil" at the "Neckar"-river. His ancestors rest in a crypt of the "Falkensteiner"- Church in the valley of "Berneck". The church has been dedicated to the holy "Erasmus".

Various commemorative plaques remind on the successful work of this noble benefactor.

"Traveller when your time allows,
direct your steps to the peaceful crypt
far away from hectical everyday life"

The ruin "Hohenschrammberg" and the the ruin "Schilteck" as well have been transferred under the authority of the city of "Schrammberg" as a gift.

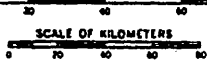

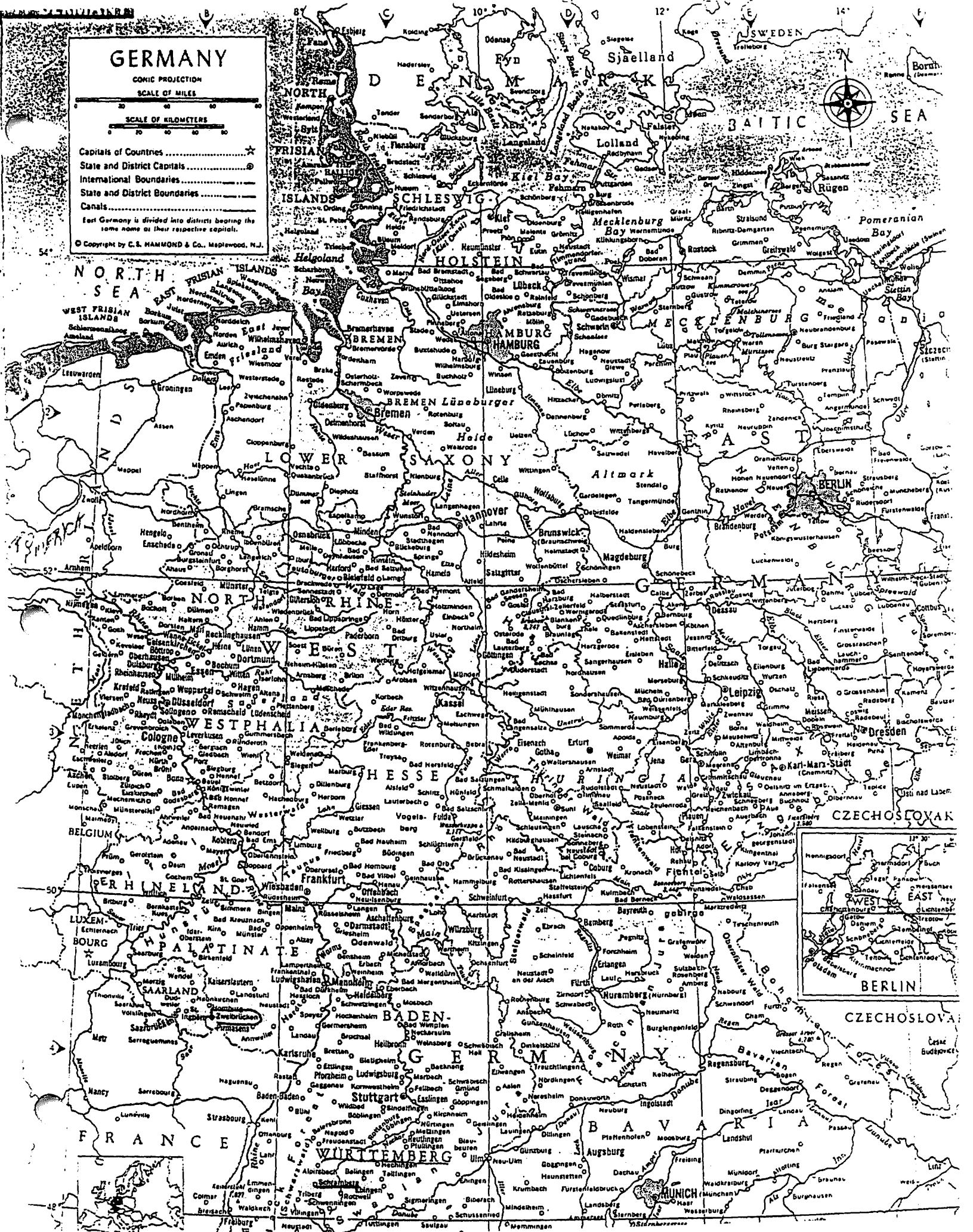
CONIC PROJECTION

FOSTER, CHARLES

F297

Foster Falls located near Highway 150, between Jasper and Tracy City was home to Charles Foster for over forty years.

He was born on January 30, 1802, near Saint Stephen's Chapel in London, England. Charles was the son of Robert and Jane Foster. He had at least two sisters. Mary Ann married Charles Powell, a confectioner and emigrated to America. Louisa married a Walsh, and lived in Melton Mowbray, England. There were possibly two brothers, named Robert or James.

On September 6, 1823, Charles married Ann Augustus Smith, the natural daughter of William Townsed Aiton, who was the son of William Aiton, one of the royal gardeners of King George III. Charles Foster, Jr. was born on February 28, 1826, in Birmingham, England.

On September 15, 1835 the family left England for America aboard the Packet Ship *Philadelphia*. The reason for the departure is largely a matter of speculation. The profession or position of his family in England is still a mystery. It is speculated that his father was a prominent wine merchant and that his marriage disgraced the family.

The family traveled steerage and Charles wrote of this journey with great pride in his journal. "The hustle and confusion amongst the steerage passengers, particularly in their endeavors to fix themselves in their respective berths, was a picture worthy of Hogarth, though it formed one of a series which if properly delineated would immortalize any person."

The family settled in New York for a short period of time. They then traveled along the Hudson River and Erie Canal to Monroe, Michigan. There he opened a school to teach drawing and writing and continued that until May of 1837, without much success. He then took up farming with his brother who came from New York. Foster left Michigan in 1839 and headed toward Chillicothe, Ohio where he again taught drawing.

In 1840, Foster moved his family to Cincinnati, where he became associated with Thomas Affleck who was the editor of the *Western Farmer and Gardener*.

In 1850, after considerable experience as an agricultural journalist and artist, Foster was in Nashville. His wife, sister Mary Ann and her family were also residing there. In the summer of 1850 cholera was wide spread in the city and on July 8, 1850, Ann Augustus died. "She was as good hearted a woman as ever drew the breath of life . . . a lady in all her actions . . . elegant and accomplished in her manners; the marked woman from her bearing and ton in society of which she was at all times an ornament, drawing attention from her peculiar gracefulness."

During his time in Cincinnati and Nashville, Foster speculated in many land deal-

ings. In 1842 or 1843, Foster received 500 acres in Marion County for some sheep illustrations.

In July 1852, Charles was on the mountain. The Powells were also there. Charles Jr. had married and gone to Arkansas. The Powells left going to Payne's Cove and he was alone. Foster and Patterson B. West continued to speculate in land and began a bachelor life on the mountain. Foster did not like this life and made proposals to Martha Shrum who along with her sister Betsy did the washing for Foster and West. On July 7, 1853, Martha Shrum became the wife of Charles Foster. The children of this union were Francis (died young), Mary Jane, Martha, Robert, Ellen, Sarah, and Elizabeth.

Charles Foster's last entry in his diary was in July of 1865. He speaks of his account books as forming "a complete synopsis of nearly each day's transactions through a series of years". Foster discusses his great "difficulty" concerning his son Charles who killed a man while working on the North-Western railroad. This occurred around 1855 and young Charles traveled to South America during part of this time.

The last entry states that young Charles "returned to this country in time to take an active part in the struggle we have just gone through with the North. A full history of which has not yet been written but having myself played a conspicuous part in the same. I purpose at all events to record such portion of its transaction that has come under my own personal observation."

He died on February 25, 1899, the account mentioned above either never written or lost along with his many other writings and paintings.

Miss Ellen Fufts has in her possession two of her grandfather's paintings and two other paintings which are speculated to be his parents. For a full account of the contributions of Charles Foster, see the thesis of Howard Thomas Sleigh, Jr., presented to the faculty of East Tennessee State University, or the copies of the diary of Charles Foster in the possession of many of the local residents of Marion County who are his descendants.

The following article is a tribute to **Gaither Shrum** of Lincolnton, NC, who died in September 1995. This copy appeared in the Charlotte Observer, April 11, 1995.

Battleground Park to Bear Historian's Name

"He was a dedicated historian and a man very few people could forget. He believed in this cause, and he stayed with it." - Darrell Harkey

Lincolnton - Gaither Shrum got a kick out of leading tours of the Ramsour's Mill Battlefield, dressed in a Revolutionary War Costume. He acted like he'd actually been there in June 1780, and the folksy Baptist Preacher described the battle with the same fervor that flavored his sermons. For years, Shrum dreamed of developing the important but neglected Revolutionary Battle Site. It was a project he championed right up until his death of a heart attack in 1995 at age 66.

Now Shrum's dream is finally coming true. During a living history celebration on Saturday, a monument to his memory will be dedicated at a new battleground park named for him. A bronze plaque with his name will be mounted on an original stone salvaged nearly a half-century ago from the ruins of Ramsour's Mill. "This project wouldn't be possible without Gaither's influence, knowledge and research," says Darrell Harkey, coordinator of the Lincoln County Historical Property Commission. "He was a dedicated historian and a man very few people could forget. He believed in this cause and he stayed with it."

Much of the 88 acre Ramsour's Mill battlefield is occupied by Lincolnton High School, Middle School, and Battleground



Elementary School. Last month, the Historic Properties Commission got an easement that grants access to school property if the development doesn't interfere with school activities. Meanwhile, the commission has acquired and adjoining 7 acres, trails, monuments, interpretive signs and picnic tables. The commission has a \$25,000 state grant to start the work, which will continue as more local and state money becomes available. Harkey says the park won't deal exclusively with military matters, it will also cover the region's cultural history. The property includes part of the original Tuckaseegee Road running from Charlotte to the grist mill built by German immigrant Deedrick Ramsour in the 1760's.

A blacksmith Shop and general store and other shops made the location an economic focal point for decades before and after the Revolution. "What I want people to know when they stand on this old road-bed is that they're walking on the same ground as the people who shaped our nation." "Harkey says," it's a place where freedom was born. We are just getting started and there is unlimited potential as to what we can do here." That includes log cabins with permanent historical displays, along with a network of trails that will link with Lincoln's new greenway.

Long before others recognized the potential for the area, Shrum was out trying to drum up support whenever he had the chance. "He was a relentless advocate of the battlefield," says historian Dan Barefoot, president of the Historic Properties Commission. "This is a worthwhile project and we hope we can get a lot of other people enthused." Shrum was a colorful figure fascinated with local, state and national history. He founded the Historic Properties Commission and chaired the Battlefield Commission and County Historical Association. He was also a Baptist minister, an expert carpenter, former High School shop teacher and an Ex-Marine who served in World War II and Korea.

A Lincoln County native, Shrum was proud of his ancestors, who were in the area when a small Patriot force defeated a much larger army of Tories at Ramsour's Mill on June 20, 1780. Harkey recalls that Shrum really enjoyed explaining the battle and its historical context to kids. He felt a sense of urgency about protecting and marking the site for future

generations. Despite the battle's importance in rallying patriot support during the dark days of the Revolution, it was largely overlooked by local folks, Harkey says, and he thinks he knows why. "It was such a hurtful event," Harkey says. "The Revolution split families around here down the middle. Brothers fought against brothers. After the war was over, people figured the quicker it was forgotten, the better."

When Shrum gave a battleground tour, he could make it come alive from both the Patriot and Tory side and put it in a solid historical context. Things were just beginning to happen with the Ramsour's Mill development project when Shrum died. "Thanks to Lincoln County commissioners and Senator David Hoyle, the ball started rolling," Harkey says. "I think Gaither would be excited and proud. This is a way to recognize him. He was a great teacher, and history was what he was good at. He was the best."

Prospect Hill Cemetery

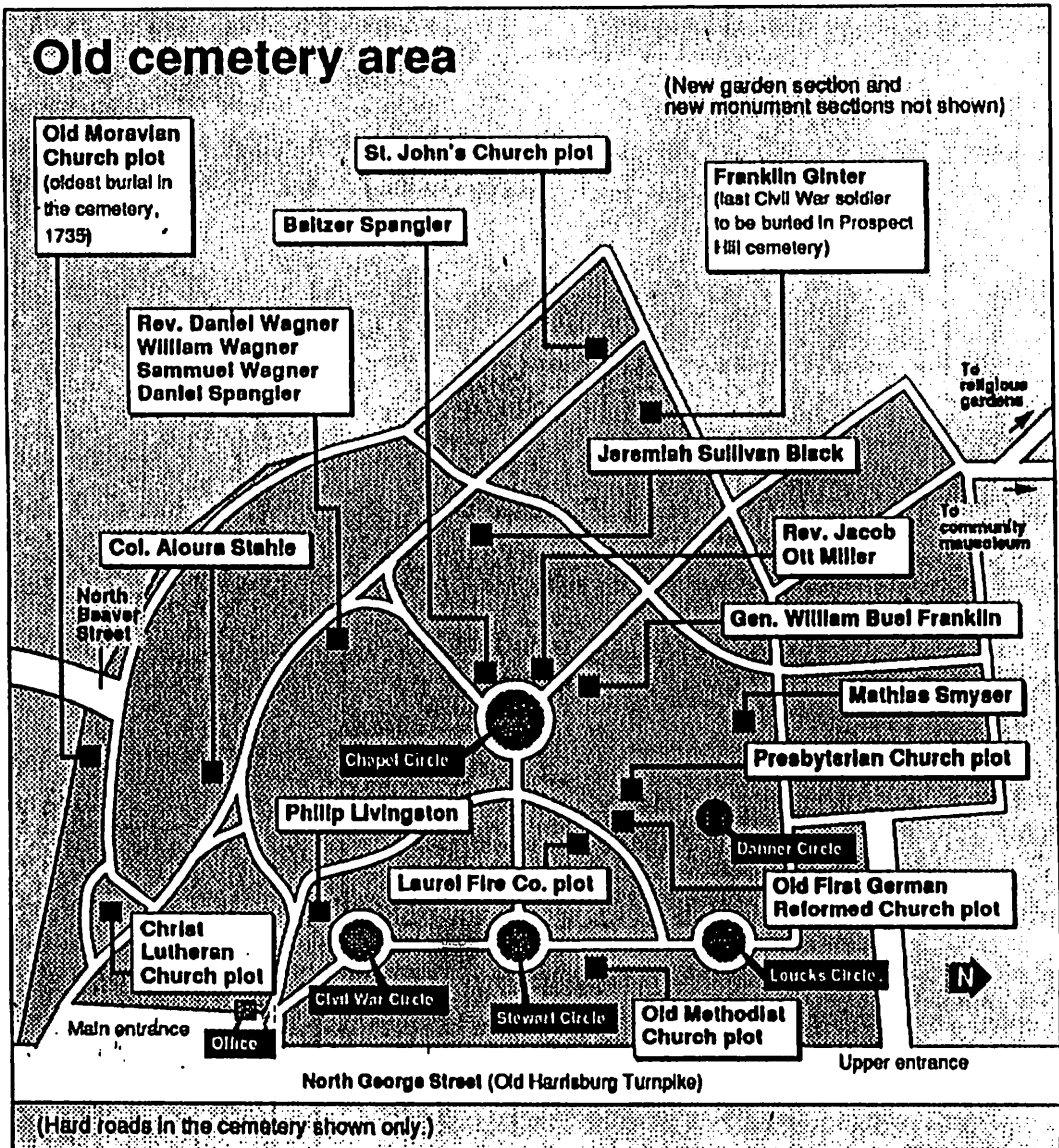
Prospect Hill Cemetery overlooks the city of York on North George Street. Prospect Hill Cemetery was chartered to the town's first Reformed Church in 1849. When the church split into separate English- and German-speaking congregations, the cemetery was claimed by the English congregation, now known as Trinity United Church of Christ. The first burial at Prospect Hill, of War of 1812 veteran Captain Enos Small, took place in 1851. Soon after the cemetery was opened, many graves were relocated to it from earlier church graveyards located on North Beaver and South Duke streets, as well as from York's Zion Reformed Church. The grave of Phillip Livingston, a signer of the Declaration of Independence who died while attending the Continental Congress at York in 1778, was moved to Prospect Hill from a cemetery on West Market Street. The final resting places of many of York's most influential leaders and citizens, including town founder Baltzer Spangler, Judge Jeremiah S. Black, and General William B. Franklin, are also found at Prospect Hill. In 1900, the cemetery contained 10,000 graves. Today, there are approximately 90,000 graves in the cemetery.

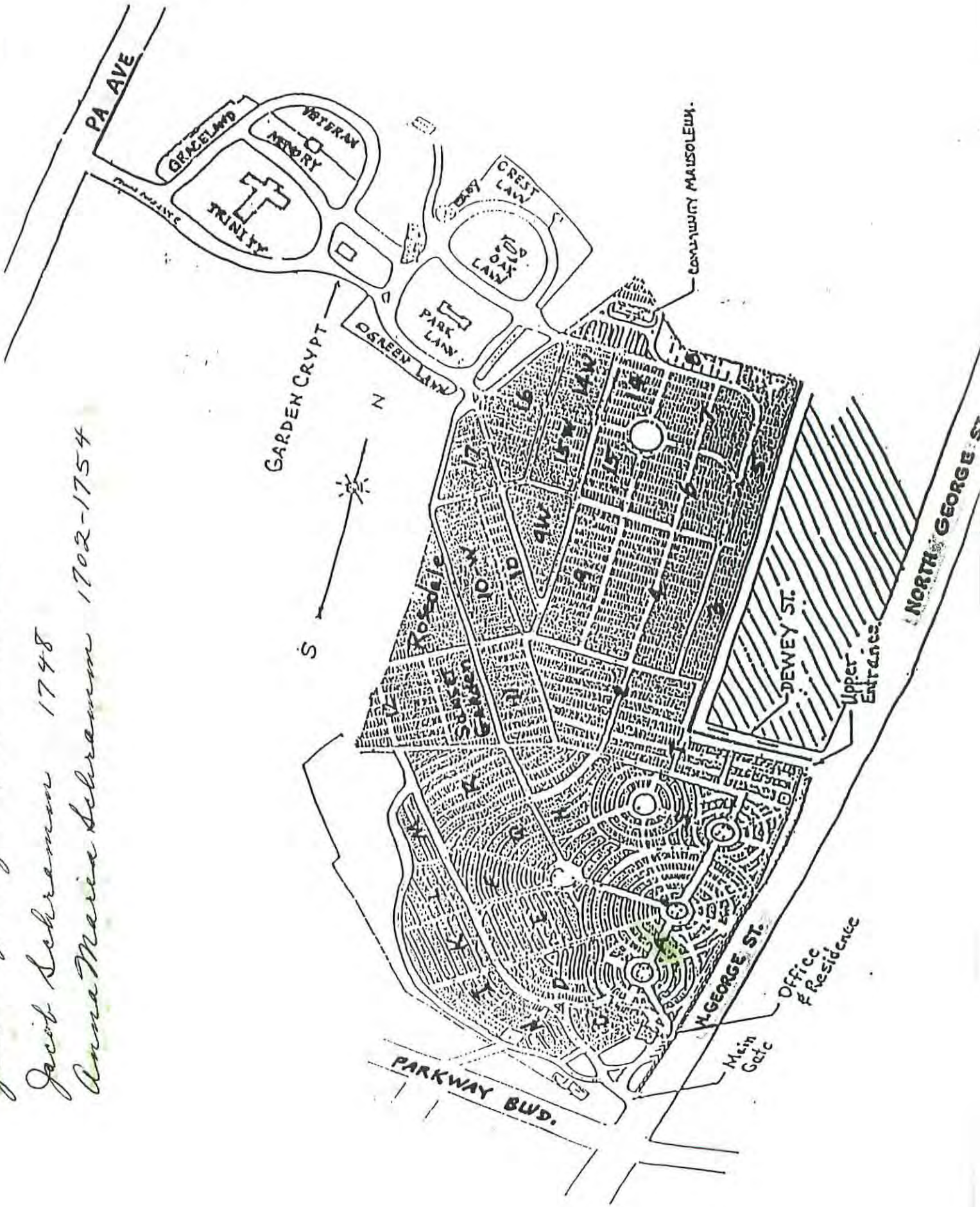
